The Standing Committee will respond to all Nominations by Petitions no later than 30 November 2018.

Instructions for Nomination: Nominations by Petition must be signed by the Nominator *and* by signature from eight (8) Petitioners representing at least four (4) of the Areas in The Episcopal Diocese of Maine. Furthermore, four (4) Petitioners must be clergy canonically resident in The Episcopal Diocese of Maine, and four (4) Petitioners must be lay delegates elected to represent their congregation at the Electing Convention.
